#### Age-Friendly Public Health Systems (AFPHS) Monthly Trainings

During emergencies and disasters, the public health system plays a crucial role in the protection of people and communities. Trust for America's Health's annual **<u>Ready or Not</u>** measures states' preparedness to respond to a spectrum of health emergencies based on nine key indicators and gives federal and state policymakers actionable data to improve emergency readiness.

The April AFPHS training will provide an overview of the 2025 Ready or Not report and include examples of state and local preparedness strategies that align with the AFPHS 6Cs Framework. The speaker for this session is Matt McKillip, Senior Health Policy Researcher and Analyst, Trust for America's Health.

**StARS Center's Dementia Care Innovation Grants** The StARS Center announced a grant funding opportunity starting in October 2025 for organizations interested in dementia care innovation projects. #### **New Funding Opportunity for Rural PACE**

The Health Resources and Services Administration announced a new Rural Program of All-Inclusive Care for the Elderly (PACE) Planning and Development grant **opportunity**. Grant recipients can use funding to develop a new PACE program or expand an existing PACE program in rural areas. Applications are due **April 17, 2025**.

#### **Caregivers**

#### **Supporting Family Caregivers with Medicaid**

The National Alliance for Caregiving published a **policy brief** on The Role of Medicaid in Supporting Family Caregivers. The brief highlights Medicaid as a primary means of support for family caregivers and home- and community-based service provision and reviews how Medicaid policy affects caregivers.

#### **Impact of Cuts to Medicaid on Older Adults**

The Milbank Memorial Fund published a blog post titled "Aging at Risk: The Impact of

Medicaid Cuts on Older Adults." The blog focuses on how potential reductions in federal spending on Medicaid would impact the caregivers who rely on Medicaid to keep older adults in their homes and communities as they age. The report highlights home- and community-based services, the direct care workforce, and Medicare access as the three benefits Medicaid cuts would most likely affect.

#### Map of Medicaid Waiver Support for Caregivers

The National Academy for State Health Policy (NASHP) and The John A. Hartford Foundation developed a **map** of existing state Medicaid waivers that support the education, training, and support for family caregivers. The map and chart highlight key differences among the 26 states that provide Medicaid coverage for these benefits and show which states have not yet implemented similar waivers.

#### **Resources for Family Caregivers**

The National Academy for State Health Policy (NASHP) created a<u>Resource Guide for</u> <u>Family Caregivers</u> based on existing resources that support the 2022 National Strategy to Support Family Caregivers. The guide provides information for caregivers about resources that help them stay healthy, socially connected, and engaged with culturallyappropriate support.

#### **Course on Providing Care to Trauma-Affected Individuals**

The Jewish Federations of North America Center on Aging, Trauma, and Holocaust Survivor Care launched a Person-Centered, Trauma-Informed (PCTI) Essentials for Aging Services <u>online course</u>. The course provides comprehensive training for caregivers and aging service organizations involved in caring for trauma-affected individuals. The PCTI approach offers a holistic approach to caregiving that promotes the dignity and agency of care recipients.

#### Infographic on the Burden of Chronic Disease

The National Institute for Health Care Management Foundation published a<u>new</u> infographic on the growing burden of chronic diseases. The infographic showcases statistics about chronic disease prevalence, risk, cost, and disparities. The tool can be used to provide chronic disease education and advocacy.

#### New Video on Shifting Language about Health Conditions

The National Center to Reframe Aging released a new**video** on shifting language on health issues as part of its frame of mind series. The video addresses societal beliefs about health conditions as an individual burden as opposed to a public health concern. It also shows how to use language to shift perspectives on health services and supports for people across the lifespan.

#### New Online Course on Elder Abuse

ADvancing States iQ Online Learning Center, in partnership with the National Center on Elder Abuse, published an updated introductory course on elder abuse for individuals in the aging and disability fields. The course, **available on ADvancing States' online learning system**, will explain the impact of elder abuse and strategies to address it. Key topics include protective factors, consequences, and responses to elder abuse.

#### **Digital Nutrition Services**

The Center for Health Care Strategies published a **profile** on the Attane Health and Anthem Blue Cross Blue Shield's partnership that focused on providing digital-driven nutrition services in Jefferson County, Kentucky. This pilot program supported the provision of home-delivered groceries and tele-nutrition coaching to 66 Medicaid enrollees in the state with diabetes who are experiencing food insecurity. The key results from this pilot included behavior change (e.g., eating healthier foods) and reduced food insecurity for the participants.

#### **Intensive Outpatient Services Coverage Changes**

The Center for Health Care Strategies published a new **brief** on recommendations for states on changes in coverage for intensive outpatient services. As of January 2024, Medicare provides coverage for intensive outpatient services which may impact Medicaid and state budgets, thus affecting dual-eligible beneficiaries and access. The brief provides recommendations for states interested in improving awareness about coverage changes, data sharing, and other implementation details.

#### **Emergency Preparedness in Nursing Homes**

In March of 2025, the Office of Inspector General (OIG) released a<u>report</u> that revealed a gap in nursing home oversight of emergency preparedness assessment. According to the report, one in four state agencies lack to the expertise to determine if nursing homes are
