Trust for America's Health has recently released the 18th annual <u>State of Obesity:</u> <u>Better Policies for a Healthier America</u>. One of the major findings noted in this report is that social and economic factors linked to obesity were exacerbated by the COVID-19 pandemic. The obesity rates for every state and the District of Columbia, and by racial and ethnic groups, age, and gender are included in this report. TFAH offers policy recommendations for federal, state and local government, and across several sectors, on how best to address the social determinants of obesity.

Age-Friendly Public Health Systems Monthly Trainings

Recent data shows that falls among older adults have increased since the COVID-19 pandemic due to social isolation and decreased physical activity. Falls can significantly impact older adults' ability to live independently. Public health evidence-based interventions are key in reducing and preventing falls. TFAH's October AFPHS training will feature Dr. Robin Lee, Team Lead, Division of Injury Prevention at the U.S. Centers for Disease Control and Prevention's (CDC) National Center for Injury Prevention & Control. Dr. Lee will highlight the strategies for fall prevention, with a specific focus on CDC's Stopping Elderly Accidents, Deaths & Injuries programs.

Funding Opportunity – Request for Technical Assistance: Infection Prevention and Control Assessment Training

The National Association of County and City Health Officials, with support from the Centers for Disease Control and Prevention Division of Health Quality and Promotion, has announced a new opportunity for local health departments (LHDs) to build infection prevention and control (IPC) capacity through partnership with Association for

Professionals in Infection Control and Epidemiology Consulting Services. The goal of this is to enhance IPC capacity in LHDs so they can better respond to infection threats, such as COVID-19 and healthcare-associated infections, in long-term care facilities. LHDs will receive technical assistance from a locally-based board-certified Infection Preventionist. The deadline for submitting requests for technical assistance is Friday, October 1st. New Issue Brief on Leveraging Funds from the American Rescue Plan Act In a new issue brief by Milbank Memorial Fund, Health Management Associates' Madeleine Shea and Aaron Tripp provide an overview of key direct and indirect American Rescue Plan Act (ARPA) provisions that could be leveraged to support older adults. A framework to assist state government officials as they refine their plans to incorporate various strands of ARPA support is also included.

The Impact of the Pandemic on Social Isolation and Loneliness
Older adults across the country have struggled with pandemic isolation and the
overwhelming feeling of loneliness due to decreased social engagement
opportunities. Results from a survey by the AARP Foundation and the United Health
Foundation found that those over age 50 went a month or more without human
interaction. Lower income older adults and women are more likely to mention social
isolation and loneliness.

Older Adults want Health Workers Vaccinated

Results from the National Poll on Healthy Aging found that **80% of adults age 50 to 80 believe health care professionals should receive the COVID-19 vaccine**. Some additional key findings from this survey note that views differed by race and ethnicity - 5% of Black respondents, 57% of white respondents and 65% of Hispanic respondents favored a vaccine requirement for health care workers. In addition, 72% of 65- to 80-year-olds said health care workers should be required to take the vaccine, compared with 52% of 50- to 64-year-olds.

Programs of All-Inclusive Care for the Elderly Quickly Pivot

The COVID-19 pandemic provided an opportunity for Programs of All-Inclusive Care for the Elderly (PACE) to provide creative solutions for home-based care. **Altarum evaluated three-quarters of PACE sites nationwide** to understand how they were able to respond quickly to safely provide care for their participants. Using both qualitative and quantitative methods, PACE outcomes were compared to those of similar beneficiaries who received care outside of the program to examine the potential to expand some helpful adaptations to other parts of the long-term care system. The Villages in Florida is a 55 and older retirement community that attracts older adults from around the country. But Chairman Paul Irving of the Center for the Future of Aging considers the benefits to older adults of living in a multi-generational, more racially and ethnically diverse community in this **article**. Examples of such living options are provided including university-based retirement communities.

New Issue Brief on Expanding Paid Leave Plan

Developed by the National Partnership for Women & Families, Our Aging, Caring Nation: Why A U.S. Paid Leave Plan Must Provide More Than Time to Care for New Children examines the coming increase in caregiving needs in the United States and the lack of access to paid family and medical leave making it challenging for aging individuals to receive adequate care. The brief also notes several key findings, including the projection that "Alzheimer's disease among people ages 65 and older is projected to double from six million to nearly 13 million by 2050, increasing health care and long-term care costs from \$355 billion a year in 2021 to more than \$1.1 trillion in 2050."

Blog Highlights Obstacles and Opportunities for Addressing Social Determinants of Health

It has become widely understood that addressing social determinants of health (SDOH) is critical to improving health and health equity. There is, however, a lack of rigorous research evidence that demonstrates the effects of SODH interventions. **A recent Journal of the American Medical Association blog** calls for more data sharing and collaboration to address this lack of research.

Socially Isolated Older Adults at Higher Risk after Hospitalization Results from a study by researchers at the University of Maryland, Baltimore and Yale School of Medicine found that social isolation among older adults following an intensive-care stay was associated with an increased risk of serious disability and death. Data from 997 older Americans who were admitted to an ICU in 2011 through 2018 was examined. Despite how prevalent this issue is, researchers in this study note that there are very few effective interventions to address it.
