Upcoming Webinar – Three Keys to Cross-Sector Age-Friendly Care – Thursday, October 26, from 2-3:30 pm ET. The Institute for Healthcare Improvement (IHI) and Trust for America's Health (TFAH) are pleased to invite you to a webinar on the Three Keys to Cross-Sector Age-Friendly Care. This effort was the result of a collaboration between IHI, TFAH, and the Michigan Health and Hospital Association, with funding from the Michigan Health Endowment Fund. The Three Keys resource is designed to foster collaboration across the older adult care continuum, promoting system changes that will lead to an optimal care journey for older adults and their caregivers. It includes concrete guidance for health systems and public health agencies, as well as community organizations to identify and prioritize activities in healthy aging. Attendees will learn about the development of related resources and the value of implementing the change ideas designed specifically for each sector. Healthy People 2030 Healthy People in States and Territories Page The Office of Disease Prevention and Health Promotion has launched anew page -Healthy People in States and Territories. The page provides an overview of the Healthy People State and Territorial Coordinators, a list of available health improvement plans, and links to relevant leading health indicators.

New Health Equity Video A new video – <u>"5 Things to Know About Health Equity"</u> – emphasizes the importance of health equity in improving national health goals. Developed by the Office of Disease Prevention and Health Promotion, this video emphasizes that "achieving health equity requires valuing everyone equally with focused and ongoing societal efforts to address avoidable inequalities, historical and contemporary injustices, and social determinants of health — and to eliminate disparities in health and health care." This short video also includes strategies for how organizations can use Healthy People 2030 to improve health equity.

Data

2022 BRFSS Data Available
2022 Behavioral Risk Factor Surveillance System (BRFSS) dataset and
prevalence tables are now available. The BRFSS online prevalence tool supports stateand topic-specific data analysis, state-to-state, and state-to-national comparisons. This

and topic-specific data analysis, state-to-state, and state-to-national comparisons. This dataset can also be used to view survey results from more than 445,000 participants across all 50 states, DC, and participating US territories. One of the new elements in this version of the dataset is the BRFSS Social Determinants & Health Equity and Reactions to Race optional modules.

Importance of Increasing Health Data Availability in U.S. Territories

U.S. territories tend to receive diminished visibility in health data relative to states. This results in a limited ability of federal and territorial governments to respond to health emergencies. A recent article in the Journal of the American Medical

Association co-authored by the Association for State and Territorial Health

Officials staff provides recommendations and strategies to strengthen

territorial visibility. The three recommendations are: 1) encouraging elected representatives to advocate for the examination of federal laws and policies that contribute to territorial health-related data gaps 2) increasing workforce capacity by growing the number of US National Health Service Corps and/or Commissioned Corps members in the territories; and 3) including territories in funding efforts similar to the Centers for Disease Control and Prevention's Strengthening US Public Health Infrastructure, Workforce, and Data systems grants.

Long-Term Services and Supports (LTSS) Choices and Scorecard Tools Site The newly released 2023 edition of AARP's LTSS State Scorecard shows that only five states rank as top performers as most states are falling short, especially around support for family caregivers, the long-term care workforce and equitable long-term supports and services for all. This score card is a compilation of data and analysis that provides a comprehensive picture of how states, through their LTSS systems, are supporting older adults, people with physical disabilities and family caregivers. It features interactive maps and visuals for users to see and compare state data, performance, and rankings and download state fact sheets. This tool is now housed at the new LTSS Choices and Scorecard Tools and Resources website.

Rural Health

Patching Together Health Care Options in a Rural Community
In the small town of LaFayette, Alabama, the only two primary care doctors are planning to retire but worry about leaving their community. The local hospital closed in 1988 and the nearest emergency room in another town, 20 minutes away. The residents are turning to the city fire department to fill the void. People regularly walk or drive to the fire station that is staffed with full-time firefighters and emergency medics. They have essentially developed a "de facto walk-in clinic". This option is not available in many rural communities because emergency medical services are often run by volunteers. The town also has a new telehealth service. This OnMed Care Station is a large booth stocked with a video screen and high-tech health monitoring equipment.

Kansas Health Institute Launches Podcast Focused on Rural Kansas Health on the Plains, a new podcast launched by the Kansas Health Institute, is focused on rural health challenges and opportunities in Kansas. The first episode highlighted the health on the plains through a conversation with a fifth-generation rancher; and the second episode featured Lisse Regehr, President and CEO of Thrive Allen County a rural health advocacy organization that is working to make Allen County the healthiest rural community in the state.

New Falls Prevention Guide

The Association for State and Territorial Health Officials has recently developed new Falls Prevention Guide in partnership with the Centers for Disease Control and Prevention to support and expand initiatives to address older adult falls. The guide provides resources regarding surveillance, strategic planning and evaluation, and collaboration. With this guide, state health departments will learn strategies to improve current falls prevention activities, understand approaches from different states,

develop community-clinical linkages, and learn how to leverage resources to maximize their impact.

New White Paper on Stronger Caregiver Supports

A new white paper from the Rosalynn Carter Institute (RCI) for Caregivers and ATI

Advisory — <u>Guiding the GUIDE Model Toward Stronger Caregiver Supports</u>
— provides an analysis and recommendations to strengthen caregiver supports included in the Centers for Medicare and Medicaid Innovation <u>Guiding an Improved Dementia</u>

<u>Experience (GUIDE) Model</u>. The recommendations included in this analysis are designed to strengthen specific supports for caregivers of people living with dementia. The RCI's primary recommendation is that the GUIDE Model include a rigorous assessment and indicate referrals to protect caregiver health.
