





Older Adults: Snapshot



For the first time in history, more people are over 65 than under 18



Households aged 65 and over are increasing faster than any other age group, both in number and as a share of all households



Adults aged 55 and over contributed about two-thirds of rental housing growth from 2004-2019



55+ now constitutes 30 percent of all renter households, and over 13.2 million households



Older Adults: Snapshot

- 1 in 6 live in poverty
- 96% live independently
- 20% don't drive
- 1 in 9 live with dementia
- 20% need help with ADL
- 40% have ambulatory limitations



Accessibility

- HUD research indicates less than 5% of US housing stock is "accessible" (vs. 26% of population with a disability)
- Features needed to accommodate a person with moderate mobility difficulties
- Less than 1% accessible to wheelchair users

• Approx. two-thirds of **HUD-assisted residents** are dually eligible for **Medicare and Medicaid** (Financial- and agebased eligibility)

Affordability: How do we house older adults with low incomes?

- Housing that is affordable vs.
- Housing that has flexible, stable affordability



Accessibility: How do we house older adults with accessibility needs?

- Affordable Housing (sometimes accessible)
- VS.
- Housing that accommodates (anticipates?) resident accessibility needs



Health Needs and Services:

How do we house older adults with low incomes?

Affordable housing (sometimes service-enhanced)

VS.

 Housing that centers resident health needs



Section 202 Affordability + Health + Accessibility

- Only federal housing program specifically for older adults
- Eligibility based on age and income
- Rents are deeply affordable
- Rents adjust based on both income and medical expenses
- Can't be too poor to live there
- Only 1 in 3 eligible older adults receive federal rental assistance

Digital Connectivity

- Most senior housing communities lack wall-to-wall internet
- Equity issues for housing residents: healthcare access, social & civil engagement, workforce access
- Housing operations: need for digital workorders, electronic records, risk mitigation strategies



Digital Connectivity

Solutions:

- Affordable Connectivity Program (ACP) has sunsetted
- BEAD and DEA funding for infrastructure is on its way
- State broadband office initiatives
- How do we get affordable housing to the table?



Climate Resilience and Energy Efficiency

- Impact on affordable housing portfolio
- Data points
- Preservation needs
- Property insurance
- Disaster response

Climate Resilience and Energy Efficiency

- Green and Resilient Retrofit Program
 - HUD grants and loans (program end in 2024)
- HUD energy benchmarking program
 - Free! For four years
- Other federal investments (tax credits, rebates)

Justice in Aging is a national organization that uses the power of law to fight senior poverty by securing access to affordable health care, housing, economic security, and the courts for older adults with limited resources.


Since 1972 we've focused our efforts primarily on fighting for people who have been marginalized and excluded from justice, such as women, people of color, LGBTQ+ individuals, and people with limited English proficiency.

Older Adult Homelessness




Surge in Older Adult Homelessness • 50% of homeless are age 50+, with half of those having

- first homeless incident after age 50
- Unhoused older adults often experience accelerated aging and have health conditions usually found in people 20 years older




California Example: Renters Struggle with Housing Costs

FIGURE 1 California Renters Are More Likely to Struggle to Pay Housing Costs as They Age

Note:"Cost-burdened" households pay more than 30% of their income for housing; "severely costburdened" households pay more than 50% of their income for housing.

California's Older Low-Income Renters Continue to Be Squeezed by Housing Unaffordability and Face a Growing Threat of Aging into Homelessness: <u>Justice in Aging Issue Brief March 2024</u>

California Example: Racial Disparities Of unhoused older adults in a 2023 UCSF study:

- 31% reported a Black racial identity (vs. 6% older adults statewide)
- 3% reported Native American/Indigenous (vs. 0.3%) statewide)
- 18% reported Latina/o/x (vs. 28% statewide)

Policy Solutions to End Older Adult Homelessness

Target those at the greatest risk and eliminate barriers to rehousing


Increase supply of affordable, appropriate housing

Expand federal rental assistance Integrate housing, health care and tenancy supports



Make health care affordable and accessible Strengthen income supports like Social Security and SSI
